

NAMURA TOP END KIT GIVEAWAY

Official Rules

1. Sponsor

The Namura Top End Kit Giveaway (“Sweepstakes”) is sponsored by Namura Technologies, Inc. (“Sponsor”).

Promotion administered solely by Namura Technologies, Inc. Feld Entertainment®, Pro Motocross Championship, and affiliated entities are not sponsors of this Sweepstakes and are not responsible for administration of the promotion or prize fulfillment.

2. Eligibility

Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least 18 years of age at the time of entry.

Employees, officers, directors, representatives, and agents of Sponsor, its affiliates, advertising and promotion agencies, and any entities involved in the administration or fulfillment of the Sweepstakes, as well as their immediate family members and household members, are not eligible.

3. Sweepstakes Period

4. How to Enter

Participants may enter by scanning the official Namura giveaway QR code displayed at the event and completing the online entry form.

To enter without attending an event, visit <https://www.namura.com/category/news/> and following the instructions for the Namura Top End Kit Giveaway during the applicable entry period. Entries submitted through the alternate method of entry will have the same odds of winning as entries submitted by scanning the event QR code.

Entrants must provide:

- Full name
- Valid email address
- Phone number
- Full motorcycle or ATV/UTV information, including:
 - Year
 - Make
 - Model

- Engine size

Incomplete, inaccurate, or unverifiable entries may be disqualified.

Limit one (1) entry per person per event weekend.

Multiple entries submitted by the same individual during the same event weekend may result in disqualification.

Automated, fraudulent, incomplete, altered, or duplicate entries are void.

Sponsor is not responsible for lost, late, incomplete, corrupted, misdirected, or technically malfunctioning entries or transmissions.

By entering, entrant agrees to be bound by these Official Rules and Sponsor's decisions, which are final and binding in all matters relating to the Sweepstakes.

5. Prize

One (1) winner will be selected during each applicable event weekend to receive a Namura Top End Kit compatible with the winner's submitted vehicle application.

Prize package may include:

- Piston
- Rings
- Wrist pin
- Top end gasket set
- Needle bearing where required

Approximate retail value varies depending on application.

Prize is non-transferable and may not be exchanged for cash or substituted except at Sponsor's sole discretion.

Prize eligibility and product compatibility are subject to Namura product availability and application coverage. Sponsor may, at its sole discretion, award a comparable Namura product, request an alternate eligible vehicle application from the winner, or award another prize of equal or greater value.

Winner selection will take place on the Monday immediately following each applicable event weekend.

Potential winners will be contacted using the contact information provided during entry.

Sponsor may require verification of eligibility and vehicle information before awarding the prize.

If a potential winner cannot be contacted, fails to respond within seven (7) days, or is found ineligible, Sponsor may select an alternate winner.
